Bird x Urban Circus Valentine's Day Sweepstakes Official Rules

By participating in the Bird x Urban Circus Valentine's Day ("Sweepstakes"), you agree to be fully bound by these rules, together with details announced by Bird, and represent and warrant that you meet the eligibility requirements. No purchase is necessary to enter or win, and purchase does not enhance chances of winning.

- 1. Sweepstakes Sponsor is Bird Rides Europe B.V., Rokin 92, 1012KZ Amsterdam, The Netherlands. ("Sponsor").
- 2. The Data Controller as defined by Regulation (EU) 2016/679, art 4 (7) is Bird Rides Europe B.V., Rokin 92, 1012KZ Amsterdam, The Netherlands.
- 3. Eligibility. Entry is limited to users of Instagram (the "Sweepstakes Platform"), aged 18 and older who are residents of one of the following countries : Austria, Belgium, Finland, France, Germany, Israel, Italy, Netherlands, Norway, Portugal, Spain, Sweden, UK .  - a. You must have an account on the Sweepstakes Platform in order to participate. If you do not have an account on the Sweepstakes Platform, it is free to create one. Follow the Sweepstakes details announced by Bird on the Sweepstakes Platform ("Details"), which unless otherwise specified include the following:
 - i. Like the sweepstakes photo posted by the Sponsor's official account on the Sweepstakes Platform
 - ii. Follow @bird and @urbancircus on the Sweepstakes Platform
 - iii. Tag one (1) friend in the comments of the sweepstakes photo posted by the Sponsor's official account on the Sweepstakes Platform
- 5. No Liability/Release.
 - a. By participating in this Sweepstakes, entrants agree to release, discharge, indemnify and hold harmless Sponsor and its subsidiaries and affiliates, its advertising and promotion agencies and partners (including Urban Circus, Inc. and its affiliates ("Urban Circus")), as

Winners may also be announced by Sponsor. The potential winners will be required to respond to Sponsor within two (2) days of when the initial notification was sent, and will be required to confirm several pieces of information to verify their win. The potential winners must confirm their name (first/last), mailing address, that they are 18 years of age or older, and that they agree to these Official Rules. If a potential winner does not respond to the message within two (2) days of when the initial notification message was sent, or refuses to confirm the requested information, then the potential winner will be disqualified and forfeits their right to the prize and an alternate winner may be selected. The prize will be sent to the winners at the address provided after their win is verified. Sponsor is not responsible for the prize once it has shipped, and winners are solely responsible for ensuring they can receive delivery of the prize at the mailing address they provide.

 - d. Sponsor may substitute a prize of equal or greater value for any prize that is not available for any reason.
- Prize. The winners shall each receive 1 Urban Circus bag with an approximate retail value of €100 and a Bird credit with a value of €50. Each prize has an approximate total combined retail value of €150.

 - b. By participating in the Sweepstakes, Personal Data provided by you is processed by the Data Processor on behalf of the Data Controller.
 - c. Your Personal Data will be processed for the purpose of participating in the Sweepstakes only and will be retained as long as necessary for such purpose. All Personal Data provided by you in relation to the Sweepstakes shall be processed in accordance with the privacy policy. You can request access to and/or submit a request for rectification or deletion of your Personal Data. Entrants further agree to be bound by the decisions of the Sponsor which will be final and binding in all respects.
